### **Situation**

Mott MacDonald is a global engineering, management, and development consulting firm with 180 principal offices in 50 countries and 16,000 employees. It is one of the earliest adopters of Microsoft Viva – an employee experience platform that brings together communications, knowledge, learning, resources, and insights.
